With humble submission I Thangkholun Kipgen Bongbal Khullen Village Kangpokpi District Under Maphou Police station, Manipur beg to inform you that large Number of miscreants belonging to majority Meitei community came to the Bongbal Khullen Village Kangpokpi District Manipur and burn down all properties, Houses, Documents etc. on 04-05-2023 at around 2:00 pm.

The situation was highly chaotic and could not identify the individual who committed the crime. But I can say that most of them wear black T-shirt, red marks on the back of the T-shirt. They are fully with weapons attacked and attempted our lives. We have been in the forest striving with hard for more than 3 days, After 5 days we have been shifted to K.M.C relief camp on date 08/05/2023 leaving behind all my properties.

So, kindly request you to take further necessary action on this matter. And I have enclosed the list properties looted, burnt down by the said miscreants on the same day.
