

I am to state that on 5th of May 2023 at about 4:30pm our
locality and K. Nungmanbi Village was under mob attacked by
a thousand of Miscreants belonging to valley base meetei
community organisation called Arambai tengol group, world
Meetei with an intend to kill all my family members. As a
result many house and burnt to ashes by the Mob and left
over looted. Total loses of my properties would be about
Rs 1500000/- (Fifteen Lakhs) approximately without any reason
is highly condemnable and totally uncalled for booking of the
culprits under appropriate section of the Indian penal code.

I, therefore pray that the culprits may be apprehended and
befitting punishment may be awarded as per law of the
land at the earliest.

I seek your help and kindly request you to register
my FIR in the subject matter.
