This is to report that on the 8th May, 2023 at around 03:00 p.m., a belligerent mob of Meitel community led by Arambal Tenggol and Meiei Leepun Numbering around 2000(Two Thousand) stormed my residence/House at Leingangpokpi village P.O/P.S Maphou Dam, Island Block Kangpokpi District, Manipur and engaged in indiscriminate arson, looting theft.

In the incident, all properties at my residence house is destroyed, burned and looted.

Details of properties looted are as listed below:-

- 1. 3(Three) Nos. of steel Almirah and 2 (Two) Nos. of wooden Almirah worth Rs.1,50,000/- (One lakh fifty thousand)
- 2. T.V. 43 inch worth Rs. 50,000/- (fifty thousand).

- 4. 5 (five) Nos. of wooden Bed Box and with king-size matress and blanket worth Rs.1,7,00,000(One lakh Seventy thousand)
- 5. 4 (four) nos. of Wooden Bed Box and with king-size matress and blanket worth Rs. 1,20,000/-
- 6. Traditional shawl and clothes worth Rs. 3,00,000/- (Three lakhs)
- 7. 1(one) nos. of gas stove and 4(foue) Nos. of Gas Cylinder worth Rs.40,000/- (Forty thousand)
- 8. Water motor (Tullu) worth Rs. 3,000/- (Three thousand)
- 9. Utensils worth Rs. 1,60,000/- (One lakh sixty thousand)
- 10. 4(four) Nos. of Sintex 1000 litres capacity worth Rs. 24,000/- (Twenty four thousand)
- 11. Furniture (Table, Chair, Sofa) worth Rs. 2,00,000/- (two lakhs)
- 12. Computer Set worth Rs.45.000/- (forty five thousand)
- 13. Inverter worth Rs. 5,500/- (five thousand five hundred)
- 14. Refrigerator Rs. 20,000/- (twenty thousand)
- 15. Solar lamp big size worth Rs.1,20,000/- (one lakh twenty thousand)
- 16. 5(five )Nos. of Cows worth Rs. 2,50,000/- (two lakh fifty thousand)
- 17. 3(three) of Pig Rs. 45,000/- (forty five thousand)
- 18. 2(two) Nos. of Necklace Gold worth Rs. 3,00,000/- (three lakhs)
- 19. House Residence worth Rs. 10,000,000/- (Ten Lakhs)

The total value of properties lost at my house residence is about 33,82,000/(Thirty three lakhs eighty two Thousand) only.

I, therefore, fervently request you to take further necessary action at the earliest as per law of the land.
