That, On Dated 3.6.23 at 7:00 am sharp my village  
K. Itangiang village under Island Block  
Kangpokpi District some unknown persons  
suspected to be Meitei Community forcefully  
intruded in to our village with a sophisticated  
weapons and burn down 32 (Thirty two)  
houses including church, school buildings

The loss burn down properties  
was estimated Rs. 3,80,00,000 (Three Crore  
and eighty lacs) approximately.

I therefore humbly request you to  
kindly take up necessary action legal action  
against the culprits according to the law.
