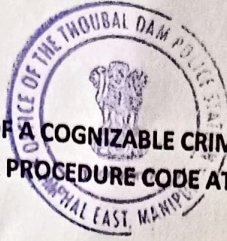

Subject:- Request for Lodging FIR

Sir,

With due respect I the undersigned would like to inform you that on 30th May, 2023 (Tuesday) at around 09:00 AM a group of Meitei Organisation numbering more than one thousand wearing State Police Commando and IRB uniform escorted by around 10 State forces Jeepsy armed with AK – 47 Rifles, SLR Rifles, M2 Carbine, and mortar cannon bombs started firing into the village accompanied by thousands of Personals suspected to be Arambai Tenggol, Kangleipak Kanba Lup, Meitei Leepun attack, ransacked, Vandalized and burnt down my village L. Songphel under Island TD Block, Kangpokpi District, comprising of 42 household, Government UJB School, School Kitchen, Anganwadi Centre, Church Building and Guest house, one distillation factory, one industry (Jojoy Enterprises) and around Five Private Vehicles Two Wheelers and four Wheelers. The estimated value of houses burning down and properties damaged is around Rs. 17,00,00,000/- (Seventeen crore) only.

It is therefore requested to lodge FIR in connection with this incident.
