at Sonombung, Imphal.

Sir,

On our way to Ukhrul from Imphal on 3rd December 2023 at around 07:00pm, the womenfolk at Sonombung, Imphal stop the vehicle where three of us were travelling. The womenfolk asked for identity card and we produced the same. However, even after being verified our identity by the womenfolk, 5 persons with arms in uniform (dark green) took us to a secluded place in their white gypsy and was beaten black and blue accusing us to be a spy or informer of Kuki. They even threaten us to shoot and place their guns in the neck. After the Tangkhul lady identity our villages through phone call we were allowed to go towards Ukhrul. By that time it was already 01:00am (04/12/2023).
