Subject: FIR Report

Sir,

I have the honour to state that, on 6<sup>th</sup> May, 2023 at around 9:00 am, miscreants belonging to Meitei community led by Arambai Tenggol and other extremist volunteers numbering more than one thousand attacked my village i.e B. Gamnom village, PO – Yairipok & PS – Maphou Dam with sophisticated weapons.

The whole village was demolished and ransacked by the attackers. A total numbers of 28 (twenty eight) houses has been burnt down with all village assets and properties including B. Gamnom Local Baptist church, Community Hall, Church Guest house, granaries and domestic animals. The estimated loss of the village is approximately 6,00,00,000/- (six crores).

The incident could not be reported to my concern PS immediately and timely due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.
