Subject: Report

Sir,

With due respect, I would like to lodge a complaint in connection with an unlawful and inhuman act.

That, on 30th May 2023 at around 10:00 AM, miscreants belonging to Meitei community numbering about 1000 suspected to be a members of Arambai Tengol and other Extremist Volunteers by holding sophisticated arms attacked our village i.e L. Molnom Village, PO-Yairipok, PS- Maphou Dam. In the incident, the miscreants have ransacked my house, looted household properties like Furniture items, Almirah, Kitchen and Utensil items, Clothes and Garments, Gongs, Ancestral necklace, Domestic animals, Grains and Rice and other properties. The miscreants later burnt down the house to ashes. The approximate value of the lost/damaged properties is estimated to be about 15,00,000/- (Fifteen Lakhs).

The matter could not be reported at my concern PS and in time due to the prevailing law and order of the state.

I, therefore request you to kindly take necessary action in this regard.
