Sir,

On the fateful day of 30th May, 2023, around 03:40 PM, thousands of youth suspected to be 'Arambai Tenggol' group from the Meitei community along with Meitei militant, carried sophisticated guns, ammunitions and other deadly weapons, attacked the Maphou Kuki Village, Saikul Sub-division, Kangpokpi District, Manipur. We fled and hid in dense forest to save our life. They had destroyed locked doors, looted every pieces of our properties, burnt down houses including mine all the remaining valuable properties were turn to ashes

Details of destroyed/looted items:

Residential wooden House, Almirah, Beds, Sofa set, Bench & tables, TV Set, Kitchen wares, Washing machine, Gas cylinder-3 with stove, all documents/certificate/Refrigerator, Paddy (Rice)-50 sacks, Pucca toilet & Store Room, Carpentry & all workshop tools & machinery, All valuable/invaluable items in the households were completely destroyed.

The approximate value of total losses in ₹ 39,00,000/- (Rupees Thirty nine lakhs)

I therefore request to booked the culprit and take necessary action as per the law of the land.
