Sir,

I have the honour to state that, On 29-05-2023 at around 3:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered my Village at S.Bongjang Village under Kangpokpi-Dist. Manipur about 47 km South from Saikul-PS. They burnt my house to ashes after vandalising and looting all the moveable properties, Furnitures, Jewellery, Utensils, Clothes, important document, Kitchen Wares, Electrical and Electronic items, Books, cash, including for newly construction of houses material like tile, cement, iron, brick, domestic animals 8 -Bufalloes, 4-cows, 6-pigs and leaving us homeless.

The approximate value of lost property is calculated at about Rs.1, 20,00,000./-(One crores and twenty lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
