I have the honour to state that, On 7-05-2023 at around 4:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered my residence house at Molkonbung Village, Island Sub - Division Kangpokpi District, Manipur about 47 km East from Saikul-PS. my house to ashes after vandalising and looting all the moveable properties Furnitures, Jewellery, Utensils, Clothes, important document, Kitchen Wares, Electrical and Electronic items, Books, cash, including two wheeler 2 Nos and dosestic animal and leaving us homeless.

The approximate value of lost property is calculated at about Rs 50,00,000./-(Fifty Lakhs

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
