Sir,

I have the honour to state that, On 7-05-2023 at around 4:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered my residence house at Molkonbung Village, Island Sub – Division Kangpokpi District, Manipur about 47 km East from Saikul-PS. They burnt my house to ashes after vandalising and looting all the moveable properties like. Furnitures, Jewellery, Utensils, Clothes, important document, Kitchen Wares, Electrical and Electronic items, Books, cash, including two wheeler 2 Nos and domestic animal and leaving us homeless.

The approximate value of lost property is calculated at about Rs 50,00,000./-(Fifty Lakhs

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
