

Sir,

I have the honour to state that, on 5th May, 2023 at around 2:30PM and on 29th May, 2023 at around 11:00 AM some miscreants belonging to Meitei/Meetei youth of World Meitei Council (WMC), Meitei Leepun and KangleipakKanbaLup (KKL) and especially Arambai Tenggol group numbering about 1000 members in all carrying sophisticated weapons like AK Rifles, SLR, .303 Rifles, sticks and iron rod enter our school E.M. Standard High School, KamuchingThiamdawi, Board Recognition No. G/54/01/349/, 2002 started ransacking, looting and then burnt down. The list of the stolen/burnt down properties are shown in **Annexure-I with an approximate value of Rs. 3,33,88,000/- (Three Crores Thirty Three Lakhs and Eighty Eight Thousands only)**

Such a gruesome attacked and barbaric act on an Institution which is highly regarded as the Temple of human and. The school had produced many official and had contributed a lot in the society as a whole especially in our area. I would like to question why the school is burnt? What will the future of those innocent school children enrol in the school? Does the school looting, ransacking and burning down all the properties without any reason could bring development?

It is highly condemnable and totally uncalled for and tantamount to criminal act which calls for booking of the culprits under appropriate section of the Indian Penal Code. I, therefore, pray that the culprits may be apprehended and befitting punishment may be awarded as per law of the land at the earliest.

I seek your help and kindly request you to register my FIR in the subject matter. Hope you will do the needful favourably at the earliest.


