It is inform with complaint to you that, on 30<sup>th</sup> May 2023 at around 3:00 pm, a group of Meitei organization numbering more than 1000 (One Thousand) people suspected to be Arambai Tenggol, Kangleipak kanba lup, Meetei leepun and other extremist volunteers by firing various automatic rifles attacked our village i.e Kamu Saichang, PS- Maphou, Kangpokpi District. They have Vandalized my house, looted my household properties and finally burnt down my house, granary store and remaining household properties into ashes.

The Approximate total cost of my property lost is about Rs. 10 Lakhs (Ten Lakhs only).

I could not report the incident to my concerned Police Station in time due to the prevailing law and order situation in the state.

I would therefore, request your good office kindly to take up further necessary action in this regard for which I shall remain ever indebted to you.
