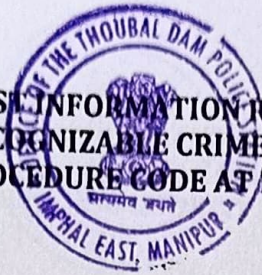

With due respect, I have the honour to state that, on the 5th June, 2023 at around 1:30 pm, miscreant numbering more than 1000 people from Meitei Community suspected to be member of Arambai Tengol, Meetei Leepun and other Extremist volunteers by holding deadly weapons like Automatic Rifles attacked over village i.e Bongbal Kholen village under Saikul Sub-Division Senapati(Kangpokpi) District.

In the incident the miscreant have burnt down my house along with all my household properties worth Rs. 35,00000/40,00000/- lakhs (thirty five lakhs to fourty lakhs)

The incident could not be reported immediately due to insecurity of our lives and volatile situation in the area.

I therefore, request you to kindly take up necessary action against the miscreant involved in the commission of crime.
