They forcefully entered our village i.eKamuching Village having around 150 houses under Saikul Sub-Division, Kangpokpi District Manipur about 25 Km from South East Maphou Police Station.

After looting all the movable properties including domestic animals and cattle's they vandalised and burnt down my house. The approximate value of properties destroyed estimate calculate at about Rs.60,00,000/- (Rupees sixty Lakhs).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
