With due respect, I have the honour to state that on the 4th May 2023 at around 4:30 pm by the Meitei community Arambai Tenngol, Meitei Leepun and Meitei militant holding deadly weapon including Automatic Rifles attack our village i.e. Kamuching Village, Island Block, Saikul Sub-Division, Kangpokpi District. They robbed, demolished and burnt down my house along with the following properties. The details are as under:

The Total amount of destroyed properties are estimated at Rs 12,64000/- (Rupees Twelve lakh Sixty four thousand) only. The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.


I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime. Thanking you Sir.
