They forcefully entered our village i.e Kamuching Village having around 80 houses under Saikul Sub-Division, Kangpokpi District Manipur about 25 Km from South East Maphou Police Station.

After looting all the movable properties including domestic animals and cattle's they vandalised and burnt down all the village houses including mine along with my vehicle No. MN01M 5110. The approximate value of properties destroyed estimate calculate at about Rs.55,00,000/- (Rupees fifty five lakhs).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
