Subject: Report on lost of movable and immovable properties.

Sir,

I have the honour to state, on Date 04/05/2023 at around 2:00 PM Some unidentified groups suspected to be the members of Meitei Organisation such as Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tengol about 1500-2000 people, carrying sophisticated weapon. They forcefully entered our village i.e Kamuching Village having around 80 houses under Saikul Sub-Division, Kangpokpi District Manipur about 25 Km from South East Maphou Police Station.

After looting all the movable properties including domestic animals and cattle's they vandalised and burnt down all the village houses including mine. The approximate value of properties destroyed estimate calculate at about Rs.50,00,000/- (Rupees fifty lakhs).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
