Sir,

With due respect, I have the honour to state that, on the 5th May, 2023 at around 2:00 PM, miscreants numbering more than 500 people from Meitei community suspected to be members of Arambai Tengol, Kangleipak Kanba Lup, Meitei Leepun by holding deadly weapons like Automatic Rifles attacked our village i.e Kamuching Village, PO – Yairipok, PS – Maphou Dam, Kangpokpi District. The miscreants have looted my household properties and our livestock and finally burnt down my house and left behind properties into ashes.

The approximate amount of my lost properties are estimated at Rs. 5,00,000/- (Rs. Five Lakhs only).

The incident could not be reported immediately to my concerned PS as well as in time due to the prevailing law and order situation in the state.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.
