FIRST INFORMATION REPORT (FIR)

Respected Sir,

With regard, I have the honour to state a few lines regarding torching down of my house (including all movable/immovable property) on 04th May, 2023 due to mob lynching led by Manipur Police Commando consequent upon Manipur High Court Order directing state govt. to submit requisite documents for inclusion of Meiteis community (General) in Schedule Tribe (ST) list filed by Scheduled Tribe Demand Committee, Manipur (STD CM), for lodging FIR and further course of action, please.

I was keeping my family at Mantripukhri Vaiphei, Imphal for the purpose of schooling of my children since 2017. On 3rd May 2023, consequent upon the rising of prevailing communal riot in Manipur, all my properties were arson down by the unruly mob & volunteer assisted by the state police. During, the massive burnt down of houses several properties have been torched to ashes as details given below which I have been accumulated during my entire service:-
