FIRST INFORMATION REPORT (FIR)

Respected Sir,

With regard, I have the honour to state a few lines regarding torching down of my house (including all movable/immovable property) on 04th May, 2023 due to mob lynching led by Manipur Police Commando consequent upon Manipur High Court Order directing state govt. to submit requisite documents for inclusion of Meiteis community (General) in Schedule Tribe (ST) list filed by Scheduled Tribe Demand Committee, Manipur (STDCM), for lodging FIR and further course of action, please.

On 4th May 2023, consequent upon the rising of prevailing communal riot in Manipur, all my properties (including shop & household goods) have been looted by the unruly mob & volunteer assisted by the state police at Nongpok Keithelmanbi, Bazar PO & PS-Yairipok, nearer to PS-Maphou, distt- Imphal East, Manipur. During, the massive ransacking, several properties (shop & household) details as given below are destroyed / missing:-
