Sub :Report on lost of movable and Immovable properties.

Sir,

I have the honour to state, on date 04-05-2023 at around 02:00 pm. Some unidentified groups suspected to be member of Meitei Organisation such as Meitei Leepun Kangleipak Kanba Lup, Arambai Tenggol, along with state Commando numbering about 1500 to 2000 people carry sophisticated weapons they forcefully enter our village i.e Kamuching Village having around 80 houses under Saikul Sub-Division Kangpokpi District, Manipur about 25 km from south east Maphou Police Station.

After looting all the moveable properties including domestic animals and cattle's they vandalized and burn down all the village houses including mine along with my properties and vehicles. The approximate value of properties destroyed estimate calculate at about ₹ 25,00,000/- (twenty five lakhs).

So I, therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
