- 2.That, 28th May 2023 at 4:00pm huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our Village, and in the process burnt/looted/vandalized our house and properties.
- 3. That, the above said Criminals with their inhuman activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.36.40 lakhs only.
- 4. Fortunately, me and my family narrowly-escaped from these criminals who even tried to killed us. Henceforth, we are taking refuge at Model School Molnom Relief Centre, Churachandpur
- I, Therefore , request you to register FIR and bring justice.
