Sir,

With reference to the above cited subject, I have the honor to report to you as below:

1. That, I Letminlun Touthang age 23 H/o Helam touthang belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India. By which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act 1989. Whereby, I am permanent resident of Tulchin Village, P.S yaingangpokpi, kangpokpi District.

2. That, on 28 June 2023 at 9:00pm huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our Village, and in the process burnt/looted/vandalized our house and properties.

3. That, the above said Criminals with their inhuman activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.21 lakhs only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to killed us. Henceforth, we are taking refuge at Bijang CBA Church relief Centre, Churachandpur

I, Therefore, request you to register FIR and bring justice.
