Subject : Report.

Sir,

I have the honour to state that, on 28-05-2023 at around 3:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 900-1000 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our village, Kongneh (New Saibol) village, Lhungtin Sub-Division, Kangpokpi District, Manipur And they vandalized and looted all the moveable and valuable household properties including the domestic animals and burnt down all the remaining things into ashes leaving us homeless.

Fearing loss of lives we had left our house and fled to the jungle and halt the night without any food, water and blankets and as of now we temporarily stayed at Dongsum Relief camp, Saikul under Kangpokpi District.

The list of properties destroyed or loss are mentioned in the Annexure(enclosed). The Approximate value of lost properties is calculated at about Rs. 13,27,000/- (thirteen lakhs twenty seven thousand).

Due to lack of legal knowledge I could not report in time.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
