looted properties is estimated to be about Rs. 1 crore.

As the law and order situation is not good in the  
Area, I could not complaint in my respective Police  
Station as well in time.

The following items of land and properties were  
destroyed, gutted and looted are as follows.

- 1) Household items and furniture
- 2) Two wheeler vehicle (Honda Activa 5G) Rept no. MN01F-0245
- 3) Jewellery and clothings
- 4) Others movable and immovable Assets.
