threatening of life, attempted murder by using machete
and physically assaulted by the majority meitei/meitei
community. The approximate value of lost destroyed
and looted properties is estimated to be about Rs. 5 crore.

As the law and order situation is not good
in the area. I could not complaint in my respective
police station as well in time.

were destroyed and looted are as follows:-

- 1) House hold items and furniture
- 2) Two wheeler vehicle (Honda Maestro) Regd No. MN 06 SC 0466
- 3) Jewellery and clothing items
- 4) Construction Materials
- 5) Others movable and Immoveable Assets.
