That Sir on the 4<sup>th</sup> May, 2023 around 11:00 am  
a Meitei youth suspected to be Arambai Tenggot, Kangleipak  
Kamba Sup and Meitei Leepem numbering around  
1000-2000 came to my church and my Quarter (Pastor  
Quarter) and vandalized, looted and burnt down with  
all the properties into ashes and could not be recover  
anymore. Details of damaged items are:

1. Pastor Scooter 6G Activa Honda Rs. 1.25 Crof.
2. Church Properties value of Rs. 45.00.000
3. Church Pastor Quarter properties value of  
Rs. 17.75.000.
4. All total amount Rs. 64.00.000 (Sixty-four lakh only)

I could not report the matter to my concerned  
Police Station as well as in time due to the prevailing  
law and order situation in Manipur State.

I therefore request your good office to kindly  
take up necessary legal action in this regard.
