It is to inform you that I Chimminchong Hsokip wife Thanglenat Misao residing at Chassad Avenue renting 3 rooms with 7 total family members including 4 children - (1) Haoginsao Misao (17) yrs (2) Joseph Misao (12) (3) Jakey Misao (12) (4) Jordan Misao and 3 adult (1) Thanglenat Misao (42) (2) Chinminchong Hsokip (38) (3) Lalam Hsokip under the care of Pu Thong-khohao Hsokip that on the 4th May 2023 at around 11:00 unknown miscreants of about 150 to 200 men armed with iron rods and face mask - on break and entered our house and destroyed our properties worth 65 lakh rupees approximately.

I therefore request you to look into the matter and take appropriate actions.
