Today i.e., 22nd May, 2023 at 10:20 am, received an information on the same about 10.00 am, some armed youths numbering around 3/4 male (Kuki) under the instigation of one T. Thangzalam Haokip @ T.T. Haokip aged about 71 years old s/o (L) T. Thongzalam Haokip of S. Kotlien Village, Churchandpur (Ex-MLA Henglep AC) A/P New Lambulane Imphal East turned up at Checkon Tribal Market, Imphal East and broke the peace and tranquility of the area by threatening the vendors sitting in the market from other ethnic groups to vacate the place immediately. Moreover, they had also intimidated women vendors and shopkeepers around to shut down the shops and vendors. As a result of which vendors of different ethnic groups got agitated and huge mobs out of anger tried to storm the New Lambulane area. Moreover, they had also used abusive and hatred words to womenfolk vendors from different communities at Tribal market Checkon. As a result, a tense erupted in the area.

So, a suo motto case under FIR No. 385(5)023 PRT-PS u/s 295A/298/506/153-1 IPC and 25(1-b) Arms Act is registered against the miscreants for investigation.
