I the undersigned have the honour to

with deadly weapons and sophisticated arms
including Kuki militants groups stormed to
Miti inhabited areas of Khuga Tampak, Ma
Leikai, Zoubeng on 3rd May 2023 at around
The said unidentified groups burnt down my
house at Zoubeng, Miti Leikai and shop
Churachandpur market (Old Bazar) and
all valuable items. In that unfortunate incident
have lost a total amount of Rs 40,00.
After the said unfortunate mob violence,
family are fleeing our village and my father
is taking shelter at my sister's residence
situated at Kongpal Khaidem Leikai, Imphal East.

I therefore prayed that the respected Sir may kindly initiate and take necessary legal actions against the accused people involved in the said inhuman acts and heinous crime committed by the accused people involved as per law of the land as early as possible.

I shall be grateful for your kind cooperation and necessary actions.
