with due respect, I have the honour to state that I, Mr Paojalen Haokip aged about 50 years s/o (Late) Holkhomang Haokip of Haokip Veng, Mahabali road, Sanjenthong, PO & PS: Porompat, Imphal East, Manipur would like to make complain that my house along with my school in the same 2 storey building namely "Kingdom Kids" was attacked and vandalised on 4.5.2023 at 1 pm by unknown miscreants. The miscreants/mob numbering to 50-100 persons led by suspected Arambai Tenggol vandalised the building and set on fire the whole building. The properties includes school properties, CCTV, School furnitures, electric two wheeler were looted and set on fire. The value of loss/damaged properties is estimated to be Rs 3 crores approx.

I therefore request you to take necessary action against the miscreants.
