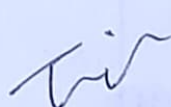

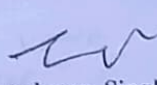

I am to state that on 4th May at around 11 to 12 noon locality Hoakip veng was under mob attacked by the of unknown miscreants belonging to the Meitei Community with an intend to murder.

As a result my house was destroyed, looted and later burnt down into ashes. in this incident properties worth 1 crores has been destroyed and looted. this include gold Jewellery, grain, Document, Vehicles, furniture, traditional ornament, Gas Cylinder, electronic items cash of ₹ 1,50,000/- loss of properties at my residence would be about 2 crores.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incidence at the earliest in the interest of Justice. I hereby lodged my complain at Kangpokpi Police station as I had fled from my residence to save myself and my families from the hoolers.
