It is to inform you that on the 4th of May, 2023 at
around 1:00pm. a group of about 1000+ Meitei mostly wear
Black shirt under the leadership of Baris Sharma with
sophisticated weapon (ex BTYM President), drambai Tenggal
Kangleipak Kamba Lup (KKL), Meitei Vepun, etc, pulled
stone and damage all the windows. Afterward the force
fully entered our house a damage our properties and
looted all our belongings and later burned down our
house i.e. Was Haokip-Veng, Imphal, Ward no. E-13. Palt
no. 304 / 545. In the incidents our property worth around
1.5 crores to 2 crores has been destroyed.

I therefore requested to lodged FIR so that proper
investigation can be done on time
