Subject: Lodging FIR over loss of house and properties

Sir,

I have the honour to state that, on 4th May, 2023 at around 1:00 PM a group of Meitei individuals numbering around one thousand attacked my residence at Haokip Veng, Palace Compound, Mahabali Road. In the process they vandalized my properties and looted all my valuables items and burnt down my house along with all my educational certificates including certificates of my brother Mr. Seilenmang Khongsai and my wife Mrs. Hatneichan Haokip.

The estimated value of properties damaged including my two wheeler (Pulsar 220F) bearing registration No. MN06SB4142 is around Rs. 10,35,000/- (Ten lakh thirty five thousand). The details and the approximate value of which I have lost are given in Annexure-1.

It is therefore requested you to lodge FIR in connection with this incident and kindly arrest all the culprits involved in this inhuman activity and punished them according to the Law of the Land.
