numbering about 800-1000 members carrying sophisticated  
weapon like AK Rifles, SLR and 303 Rifles forcefully entered  
in my house, Haokip Veng, Imphal - East Porompat,

The approximate value of lost properties is  
estimated at about Rs. 85,00,000 (Eighty five
