Subject: FIR regarding burning and looting of my house by unknown miscreants during mob violence in Imphal on 04-05-2023.

Sir,

During the recent violence in Imphal, my residence, House no: 17, Haokip Veng, Mahabali Road, PS Porompat, Imphal East, Manipur, 795005 was vandalised and set on fire by unknown miscreants on 4th May, 2023 at around 2 PM (noon) , I am submitting the following items that were set on fire and looted inside my house for your necessary action:

1. All furniture's (sofa sets, chairs, tables, beds, admirals, dining table, etc.)
2. All garments, mattresses, blankets, bed sheets, curtains, shoes, clothing's etc.
3. Electronic items such as Sony Bravia, LCD, Sony DVD player, HP Printer, computer, laptops, heaters, Nikon SLR camera, hair dryer, hair straightener, Refrigerator, washing Machine, etc.
4. Kitchen utensils, crockeries, OTG oven, Gas stoves, 5 (five) gas cylinders, water filter
5. Two Wheeler Royal Enfield bearing No: MN-1H-6400, Engine chassis no: Registered in the name of Thangchon Haokip.
6. Educational certificates, Awards of Hoipi Haokip, Leah K Haokip. Thangchon Haokip including official documents, reference books, etc.

My affected house is under the jurisdiction of Porompat PS, Imphal East, Pin-795005, as the situation is unsafe for me and my family, I am presently taking refuge in Saitu village at my relative's place.

Hence, I request you to kindly register my complaint as Zero F.I.R.
