Subject :- FIR regarding burning and looting of my house at Elim Villa, Jehova Yire Complex, Haokipveng, Imphal, by unknown miscreants during Mob violence on 04-05-23.

Sir,

This is for your kind information that during the recent mob-violence in Imphal, my residence at Haokip veng, P.S. Porompat, Imphal East District was vandalised and set on fire by unknown miscreants on 4th May 2023 at around 2 PM. I am submitting the following items that were set on fire and looted inside my house for your kind reference and necessary action.

1. Maruti Alto Car and one Access Scooty 1- **Rs.2,50,000.00**
2. Furniture : Sofa Set - 2, Dining set - 1, Dressing table - 2, Wooden Almirah - 5, King-size Bed - 1, Queen size bed - 2, Double Wooden Bed - 3, Blanket - 10, Plastic chairs - 20, TV - 2, Laptops - 2, Washing Machine - 2 : **Rs.5,90,000.00**
3. Kitchen Appliances : Refrigerator - 2, Syntax - 6, Microwave Oven- 1, Gas Cylinder - 6, Pressure Cooker- 6, **Rs.1,10,000.00**
4. Clothing items : Traditional valuable items - 8 necklaces, gold wedding ring - 2, traditional phaneks - 30, traditional shawls - 50 : **Rs.2,35,000.00.**
5. Musical instruments : Sound mixture and 2 Active Speaker, Hollow Guitar - 1, Bass Guitar - 1, Electronic Drum set - 1, Electronic Piano - 1, Bass Woofer - 1, Electric Guitar - 1, SLR Camera - 1, Two Byjus I-Pat : **Rs.3,40,000.00.**
6. The Total value of all the above items is : **Rs.14,25,000.00 (Fourteen lakhs twenty five thousand).**

The amount estimated above is not inclusive of the structural damage of the building.
