Porompat, Imphal East District was vandalised and set on fire by unknown miscreants on 4th May 2023 at around 2 PM. - 3. Kitchen Appliances: Refrigerator, 2, Syntax 6, Microwave Oven- 1, Gas Cylinder 6, Pressure Cooker- 6, Rs. 1,10,000.00
- 4. Clothing items : Traditional valuable items 8 necklaces, gold wedding ring 2, traditional phaneks - 30, traditional shawls - 50: Rs.2,35,000.00.
