report that on the intervening night of 7th and 8th May 2023
at New Checkon, near covenant school, Imphal East
that the miscreants completely destroyed all the
items inside my shops.

My shop was subjected to a horrific act of
vandalism & looting where miscreants took away every
item including Medicines and cosmetic and looted
all the valuable possess ons. This has not only caused
financial loss, but also emotional trauma for me and
my family and, the losses will not be able to recover
for the rest of my life.

Now I'm left with nothing as I had to run for my
life and had a narrow escape from death. This
horrible incident has had a profound impact on our
home as and I hold the authorities are responsible
for not providing adequate security measures to
prevent such gresome attacks from occurring.
