Nongpok Engkhrot (Chassad Avenue) Imphal East
located within PPS - Porompat. The mob looted
household belongings of Self and Tenant residents.
Following the house my house was Torched and
Mandalised. The house destroyed and property
looted is valued at 1.2 crore (approx).
