Sir,

With due respect and humble submission, I Thangmingou Mate S/O M.Jangkhonun of Chassad Avenue Imphal East, would like to file a complaint against on properties and houses damaged on the 4th and 5th 2023.

My house and properties which is located at Chassad Avenue Imphal East, have been vandalized and all properties including important personal files and documentations have been looted and destroyed as well as threatening of life and attempted to murder by the majority of Meitei/Meetei community. The approximate value of lose destroyed and looted property is estimated to be about Rs.83 Lakhs.

As below and order situation if not good in the area. I could not complain in my respective Police Station as well in time. The following items of land and properties were destroyed and looted as per as follows: -

- (1). Standing Building (Pucca, JAMABANDI, Patta No.1626) Totally Damage.
- (2). Vehicles: 2 Wheelers: a. Access 125 Disc (Alloy Wheel), Registration No.MN01AJ5236
b. Burgman 125cc, Registration No. MN06SG6733
4-Wheeler: Hyundai i-20 Sports, Registration No. MN01AS1702
- (3). Jeweller Items: Necklace which cost 4 Lakhs.
- (4). Money/Cash: 5 Lakhs.
- (5). Household items and furniture: 3 Lakhs
- (6). Others movable and immovable assests.
