Subject: Report.

Sir,

I am to report that, on 04/05/2023 starting from 8:30 am onwards, unruly mob numbering about 80 assembled at Chassed Avenue Parompat, Imphal East with an intention to cause harm and destroyed property in the locality armed with deadly weapons like sticks, iron rods and daus. The assembled mob turned violent and started vandalising ransacking and burning houses in which a good number of residential houses belonging to tribal community were burnt down to ashes. We are also a victim of such mob violence in which my residential house and valuable properties are completely destroyed by the mob miscreants on the same day.

Details of our belonging items destructions

1. Astar car b/Regd no. MN06E6534 belong to D. Yangkhosai Hachup
2. Hyundai car 20 b/Regn. no. MN01G6106 belong to Thanglinjam Hachup
3. Two wheeler Access MN01HJ+5822 belong to Mr. Letmang Hachup
4. Two wheeler Access MN06F-0672 belong to Mr. Solomon Hachup.
5. Other items and kitchen material like 3 washing machines, fridge, 4 Mixer, Godrej, 2 nos of TV flat etc. etc. was completely destroyed and some have been stolen including Gold necklace worth Rs. 1.00,000.

That the assets/property and damaged estimated to be around Rs. 40,00,000. (Fourty lakhs only) worth of me.

In this regard I would like to request you to kindly take necessary legal action against the unruly mob at the earliest.
