Subject: Report.

I am to report that, on 04/05/2023 starting from 6:30 am onwards, unruly mob numbering about 80 assembled at Chassad Avenue Porompat, Imphal East with an intention to cause harm and destroyed property in the locality armed with deadly weapons like sticks, iron rods and bats. The assembled mob turned riotous and started vandalising housebreaking and burning houses in which a good number of residential houses belonging to tribal community were burnt down to ashes. We are also a victim of such mob violence in which my residential house and valuable properties are completely destroyed by the mob miscreants on the same day.

Details of our belongings items destruction

1. A Star Car b/legd no. MN 06 16534 belong to D. Yangkhosei Haokip
2. Hyundai car iso b/legn. no. MN 01G 6106 belong to Thanglumpuim Haokip
3. Two Wheeler Access MN 01A 3+5822 belong to Mr. Detmar Haokip
4. Two Wheeler Access MN 66F - 0672 belong to Mr. Solomon Haokip.
5. Other items and kitchen material like 3 washing machine, Fridge, 4 Almirah, Godley, 2 nos of TV flat etc. etc. were completely destroyed and some have been stolen including Gold necklace worth Rs. 1,00,000/-

That the assets/ property and damaged estimated to be around Rs. 40,00,000/- (Fourly lakhs only) worth of INR.

In this regard I would like to request you to kindly take necessary legal action against the unruly mob at the earliest.
