I would like to report that on 4th May 2023 starting from 8.30 am onwards an untuly mob numbering to about 80/100 assembled at Cherrach Avenue, Porompat Imphal East with an intention to cause harm and destroyed property in the locality armed with deadly weapons like sticks, iron rods and dace. The assembled mob turned violent and started vandalizing, ransacking and destroying houses in which a good members of residential houses belonging to tribal community were demolished. We are also a victims of such mob violence in which my residential house and properties were also completely destroy by some unknown miscreants on the same day.
