Sir,

I have the honour to state, on the mid-night of 3rd May 2023 at around 9:00 pm some unknown miscreants belonging to Meitei Youth organisation suspected to be members of Arambai Tengot, World Meitei council (WMC) Meitei Leepen, Kangpokpi Kamba Lup (KKL) numbering around 500 members with deadly weapons attacked and looted our house at Gihon Villa, near KBC centre church, New Lambulane (Checkan) under Parompet Police Station, Imphal East. They looted all the valuable properties and nothing is left in the house. The approximate value of lost & destroyed properties to be about 25 lakhs.

In addition, I couldn't report the incident in time to the concerned PS due to the prevailing law and order situation.

I therefore request you to kindly registered a regular case and take necessary legal action according to law.
