Sir,

I have the honour to state, on the mid-night of 3rd May 2023 at around 9:00pm some unknown miscreants belonging to Meitei Youth Organisation suspected to be members of Aambai Tengot, World Meitei Council (WMC) Meitei Deepen, Kangleipak Kanba Lup (KKL) numbering around 500 members with deadly weapons attacked and looted our house at Gihon Villa, near USC Centre Church, New Lambulane (Chekha) under Prompet Police Station, Imphal East. They looted all the valuables properties and nothing is left in the house. The approximate value of looted & destroyed properties to be about 25 lakhs.

In addition, I couldn't report the incident in time to the concerned PS due to the prevailing law and order situation.

I therefore request you to kindly registered a regular case and take necessary legal action according to law.

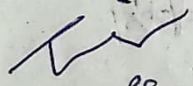
