I have the honour to report that on 03/05/2023 a group of Meitei organisation communally numbering more than one thousand suspected to be Arambai Jingo, Kanglipak Kanba Aup, Meitei Deepun attack my house and burnt down residence at New Lambulane 1/E.

They also looted all my properties and burnt down my vehicle Regd. no. BL2CAM-1942 (4 wheeler) and MNOIAC - 5899 (two wheeler)

The approximate total cost of items worth is Rs. 50,00,000/- (fifty lakhs only)

It is therefore requested to lodge FIR in connection with this incident.
