On 4th May 2023 at around 11:00 am unknown miscreant suspected to be Arambai Tenggot, Kanglukpi Kanba Lup (KNI) Meitei Keepem numbering about hundred and thousand dismantled and destroyed over building and properties i.e. vehicles, Almirahs, furnitures, Apple Laptop (Macbook) fridge, washing machine, Dunlops and many expensive things etc. The value of the lost including all properties may lost around 75 lakhs approximately.

So due to the violence eruption, I could not report the matter to my concerned Police Station at on time.
